Conference Call Attendees

Education Work Group Conference Call Highlights

The conference call participants suggested the following topics for the **June 28th meeting**:

- For the 6:00 p.m. Orientation Session Lee Lambert agreed to review CTF Accomplishments, and Tom Attridge agreed to prepare a time-line list of accomplishments and presentation slides;
- National Environmental Policy Act (NEPA) "101";
- Environmental Assessment process;
- The Technical Work Group will report on NRC's Draft Standard Review Plan and make recommendations on whether the CTF should consider submitting comments to NRC on this document by July 31st;

At a future meeting present Regulatory "102" with NRC, EPA, NYSDEC as co-presenters [may need to be more than one session]

There was discussion on the fact that an Environmental Assessment (EA) on the cumulative effects associated with facility removal at the WVDP will be coming out for public comment in

the near future. The exact date is unsure at this time, but there will be a 15 day public comment period after issuance of this EA and a public meeting before the end of the comment period. The call participants agreed that it may be necessary to set aside time at a future CTF meeting to discuss development of Task Force comments on this document. Given the short public comment period, the CTF may need to meet via conference call to develop such comments.
