DOE's Current Path Forward

- Enhanced Interim End State Actions
 - Move forward with NDA cover and slurry wall
 - Conduct pre-design characterization/evaluation for North Plateau plume containment
 - Further evaluate drying options for the underground tanks and associated liquid waste management
 - Continue DOE and NRC discussions on HLW canister on-site relocation for storage

Core Team Update

DOE's Current Path Forward (continued)

- Conduct multi-agency technical working meeting to review and discuss status and application of erosion modeling in long-term decision making at West Valley
- Continue with Decommissioning EIS; considering phased approach, with potentially issuing two Records of Decision (ROD)
 - First ROD potentially dealing with MPPB and associated facilities removal
 - Second ROD potentially for management of disposal areas and underground tanks
