




Main Plant west side after deconstruction (June 2025)


MPPB Deconstruction – Product Purification Cell (PPC)

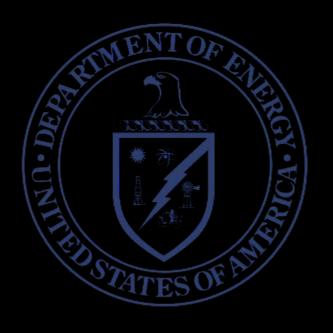


MPPB Deconstruction – Cover Installation



- Shipped a total of 162 Specialty Boxes removed from the MPPB Deconstruction Project (1827 tons)

Contract Transition

The Contract and Transition

- West Valley Cleanup Alliance, LLC (WVCA) is the new contractor, replacing CHBWV
- Contract transition began February 24
- WVCA assumed operations on June 24
- Contract:
 - 10-year ordering period with a maximum value of up to \$3.0 billion
 - Can be performed for up to 15 years
- Met with employees, union representatives, site contractors, and community



Phase 1B D&D Scope

Demolition of remaining near- and below-grade components of the Main Plant Process

Building

Contaminated soils remediation and disposition

- Waste management and legacy waste disposition
- Safeguards and security
- Tank Farm sludge removal
- Environmental monitoring
- Surveillance and maintenance
- Program support activities



Commitments/Approach

- Negotiate, manage, implement, and execute multiple simultaneous task orders to accomplish the scope of the contract.
- Embark on an efficient, below-grade demolition of main plant structures that is also protective of our workers, the public, and the environment.
- Partnering with the DOE, execute an effective plan to dispose of the roughly 30,000 cubic feet of West Valley TRU
 waste currently stored at WVDP, including the development and issuance of a final waste determination for waste
 disposition pathways.
- WVCA committed to subcontract 35% of cumulative task order value to small businesses, providing meaningful work to deliver phase 1B end states.
 - We remain committed to the existing small businesses at WVDP and will novate/assign existing contracts.
 - We plan to provide access to new subcontractors, offer new work scopes to small businesses, and create subcontracting opportunities in non-traditional roles that are focused on cost-effective delivery.
